A literature review is an outline of and blends of examination evidence relevant to a specific exploration question. It is typically created by groups of specialists, which lessens the impact of individual review creator biases and advances transparency of the review process.

The literature on interactional expertise in trading zones has a number of implications for the management of interdisciplinary teams. Addressing Bias is a week-long assignment worth 7.5% of the overall course grade. The assignment requires you to complete a self-inventory on personal biases that you hold. These biases may be implicit or explicit, and they can impact outcomes in selected nursing practice situations. Using this assignment, you will identify and discuss ways to reduce these biases in your work.

A growing body of research has examined institutional impediments to interdisciplinarity. These include existing exploration funding allocation frameworks that cheapen interdisciplinary research, scholastic promotional frameworks that encourage siloed academic work, and physical NRS 493 Literature Review like the manner in which disciplines are often housed in separate buildings on campus.

Many institutions have assets that can help lessen bias, including workshops and online training programs. These assets can be included as part of existing diversity, equity and inclusion trainings. A literature review is an analysis and synthesis of preliminary works that consolidates information on an emerging subject. It documents accumulated knowledge and reveals theoretical foundations that need to be addressed. It is a key step in novice research, helping researchers define their subject and clarify research questions. [1] It can be either systematic or narrative. The former is characterized by explicit criteria for selecting sources and well-defined information search and analysis steps. The latter is nurs fpx 4010 assessment 2 interview and interdisciplinary issue by a critical and inductive approach to analyzing the literature.

For this assignment, students should locate at least eight research articles that are relevant to their research topic (question). After locating these articles, they must photocopy them and read them. They should then use the Literature Evaluation Table to determine their relevance to the research question or purpose of their capstone project. This exercise will provide learners with an intrinsic understanding of their research topic and the most prominent researchers in the field. It will also connect them to future research "peers."

In this assessment, students will identify an issue that would benefit from an evidence-based interdisciplinary approach.
